PRESIDENT'S REPORT

CATHERINE CHEEK, WLAQ PRESIDENT & SPECIAL COUNSEL, KENNEDY SPANNER LAWYERS

With 2020 having been the year of contained celebration and closed venues, 2021 saw WLAQ sparkle and sizzle with face to face activity. The year started with a strategic planning meeting to determine the focus of 2021 which was, in addition to the objectives set out in the 2020 – 2022 plan, to assess how to manage a number of issues that had been thrown into sharp relief by working from home and the need to provide support for women lawyers who were facing bullying and harassment in the workplace.

Ann-Maree David has continued in her role as WLAQ Support Person to provide members with a contact with whom they could discuss bullying or harassment issues. Interest in an inter-organisation committee, with senior lawyers from various law firms, commenced engagement on bullying and harassment issues and we liaised with QLS into ways parental leave can be made financially easier.

The International Women's Day (IWD) event at the Banco Court in 2021, held in-person, was a wonderful evening. The annual IWD panel discussion, a collaborative event with the Bar Association of Queensland and the Queensland Law Society, was one of a number of fantastic events in which the organisations partner. On this occasion - sold out with 145 registrations - those who attended were treated to hearing how Dr Dinesh Palipana OAM, Zinta Harris, Ashleigh DoRozario and Sandra Creamer challenged in line with the #choosetochallenge IWD 2021 theme.

WLAQ held the Una Prentice Awards night in person in 2021, an event hosted by College of Law. The Una Prentice Awards are presented to the highest achieving female graduate of each university in Queensland. The awards were presented by the Hon Justice Debra Mullins, patron of the Una Prentice Memorial Trust.

The Ladder Mentoring Program for 2021 was outstandingly supported, and involved the committee organising a record breaking number of mentor/mentee relationships of 123 pairs of participants. The enthusiasm with which the women of the profession participated in this programme and the willingness of mentors to share their time and knowledge was inspiring.

PRESIDENT'S REPORT

The Gender Diversity Forum was held before the 2021 AGM at Maurice Blackburn Lawyers on 23 June 2021. This event included:

- A panel discussion with Richard Douglas, Alison Haly and Kara Thomson on managing sexual harassment and bullying in the legal profession in a workshop format; and,
- A presentation on taking the next step in your career with presentations by Dominique Lamb, Jessica McClymont and Ann Fitzpatrick involving study and learning options, moving to boards and moving through more traditional pathways and judicial appointments.

In 2021, WLAQ was approached by Suzie Miller to organise a women lawyers' theatre night for her play "Prima Facie" produced by Queensland Theatre. The topic of the play was sexual abuse in the legal profession with a Q and A to follow in which WLAQ was invited to participate. I hope that we have the opportunity to partner with other creative events in the future.

During the course of the year, WLAQ has engaged with key stakeholders to ensure that we are well positioned to promote the interests of women lawyers in the state.

The return of the Beryl Donkin Memorial Scholarship Fund was announced in 2021, with its new patron, former WLAQ President Jennifer McVeigh. We are looking forward to continuing the operation of this Fund in the years to come.

Our flagship event of the year is the Annual Awards Night and the 43rd WLAQ Annual Awards Night was a magnificent night of acknowledgment of women in the profession and a special opportunity to engage with each other. The practice of women lifting up other women is one that is very important to me and, whilst most of this occurs in unremarkable circumstances, the opportunity to celebrate this publicly was heady stuff. As motivating as such events are, I hope we do remember that, after everyone has left the room, the echo of that support remains (Emma Mactaggart, Toowoomba Zonta Woman of the Year 2021).

The activities of WLAQ in 2021 was driven by very hardworking and always supportive committee members. These women have given an extraordinary amount of time and energy to the multiple events and initiatives that have operated under the WLAQ banner. I am very thankful to you all.

I also extend that thanks to all WLAQ members and members of the legal profession of Queensland who supported our organisation in 2021.

AWL REPORT

JAMIE SHINE, WLAQ IMMEDIATE PAST PRESIDENT, AWL REPRESENTATIVE & GENERAL MANAGER - HEAD TRAUMA, SHINE LAWYERS

Australian Women Lawyers Limited (AWL) was established on 9 September 1997. AWL is governed by a board of directors comprising of representatives from each State and Territory women lawyers' associations whose goal is to be "a justice and equity champion, advancing women within the legal profession and beyond".

The Annual General Meeting for AWL was held on 23 November 2021, where the executive committee listed below remained for a further term and new committee members were appointed:

The Board has been extremely active in the past year providing comments and submissions in areas particularly relevant to sexual harassment in law and the workplace, giving a voice to not only women in law but to all Australian women, referring to its previously published Seven Strategies for Addressing Sexual Harassment in the Legal Profession. AWL REPORT

The major work undertaken by the board in the past year has been related to planning AWL's first in-person event since 2018, that is our 2022 National Conference. The Conference will be hosted in Brisbane and be held on 5 -7 August 2022. The theme of the conference is: **Securing a safe, just, and equitable future for women**.

AWL is delighted to confirm that the keynote speech at the Conference will be delivered by our Patron, the Honourable Chief Justice Susan Kiefel AC.

The Conference will include a welcome function on the first evening, a full day conference on 6 August 2022, followed by the Conference Gala Dinner. The conference will be held both in-person and online due to the ongoing impact of Covid restrictions during the planning phase of the Conference.

The Gala Dinner will be held at Custom's House and feature the presentation of the AWL Award. The Award recognises women who have provided long-term leadership and commitment in the support and advancement of women in the legal profession. AWL have secured comedian and lawyer, Steph Tisdall as the keynote speaker at the Gala Dinner.

The Conference will host a range of sessions focussing on a mix of substantive law, with women lawyers who are expert in their fields leading the discussions, and equity and human rights focussed sessions consistent with our organisation's objectives.

AWL is excited to put their planning in 2021 into action at the 2022 AWL Conference!



MEDIA REPORT

KIRSTEN VAN DER WAL, WLAQ MEDIA ADVISOR & ASSOCIATE, MAURICE BLACKBURN LAWYERS

WLAQ continued to work to publish community-oriented content with a view to celebrating inspiring Queensland women, promoting achievements and appointments within our professional and advising our members of the support and resources available to them, with a particular focus on inclusivity for regional members and the promotion of events that would be of benefit to our members throughout Queensland.

We reached over 4,300 followers on Facebook, over 4,400 on LinkedIn and over 1,000 on Twitter. From January 2021 to December 2021, we saw a large increase in followers and engagement with our posts across all social media platforms, in particular Facebook and LinkedIn and we thank our members for their continued support.

We used our social media platforms to regularly provide information regarding the available resources and events for members including the IWD Panel Event, LinkedIn Marketing for Students and Early Career Lawyers event, Gender Diversity Forum, Women at the Bar event, Criminal Lawyer specific events, fundraising details for the WLS and Dancing CEOs event and shared other important resources including the WLAQ maternity jacket, details on how to access the inaugural WLAQ support person and the WLAQ female barristers list.

The WLAQ shared updates regarding COVID-19 lockdowns and the resources available for our members during the challenging periods of lockdowns.

The WLAQ sought feedback and shared the published submissions the organisation made with respect to the Judges' Pensions Amendment (Pension Not Payable for Misconduct) Bill 2020 and the Women's Safety and Justice Taskforce. The WLAQ shared a survey with its members to seek input from female lawyers who shared their experiences or insights into the justice system and we collated this information as part of our submissions.

The WLAQ shared the Ladder Mentoring Program across our social media platforms and had a record year for mentor/mentees with a total of 250 women being involved in the 2021 Ladder Program.

We continued our WLAQ Inspo List, aimed at celebrating women who hold a law degree, are either from or based in Queensland, and have inspired the WLAQ Committee. The list was released to coincide with IWD to express our thanks to firms, chamber groups and other organisations for contributing to the 2021 theme.

We were also able to return to our in person Annual Awards Dinner and celebrate the many incredible women within the legal profession and share the results across our social media platforms.

In 2021, we were pleased to promote inspiring women both via these platforms, and internally, with some notable mentions including:

- The Honourable Justice Kylie Downes who was appointed to the Federal Court of Australia;

ADVOCACY REPORT

JESSICA MCCLYMONT, WLAQ VICE-PRESIDENT & BARRISTER, HEMMANT'S LIST

WLAQ continued its efforts to support women advocates and to advocate for women. WLAQ persisted to advocate for equitable briefing of women barristers in maintaining and regularly updating a list of female barristers which is available to the public on our website.

The Pregnancy Bar Jacket was utilised for a good part of 2021, and now remains in its permanent home in the Inns of Court so as to be proximate to the Brisbane court precinct.

WLAQ received a number of notifications of legislative changes and enquiries, many of which were outside our core focus and circulated among our members for their interest. That being said, in January 2021, WLAQ formulated submissions as to proposed changes to the legislation governing judicial pensions, in the event of serious misconduct. WLAQ was able to provide data from its 2019 survey of female criminal lawyers to inform the Senate Committee investigating that issue.

In July 2021, the Criminal Law sub-committee put an enormous effort into submissions to the Women's Safety and Justice Taskforce.



In November 2021, we were also excited to host the Women at the Bar event after a two year hiatus. It was a wonderful evening to connect solicitors and female barristers!

In the forthcoming year, WLAQ will continue to be involved in responding to proposed legislative changes and matters concerning our members. The Management Committee members are available to all members to consult and work with on any areas of the profession that are a cause for concern.

DIVERSITY REPORT

MAGISTRATE DZENITA BALIC, WLAQ DIVERSITY ADVISOR & MAGISTRATE

The journey of diversity was outstanding in 2021.

Firstly, we commenced with WLAQ's vital submission regarding serious misconduct for judicial officers and consequences that flow from that.

We also provided a submission to the Women's Safety and Justice including a focus by the criminal sub-committee on women from non-English speaking backgrounds.

Our focus on diversity channelled itself through a couple of speaking arrangements by me on behalf of WLAQ to highlight how WLAQ can enhance the space for diversity within the legal profession through our reach across Queensland. In particular, WLAQ has strengthened its connections with Pride in Law, the Asian Australian Lawyers Association, the Indigenous Lawyers Association Queensland, the Pasifika Lawyers Association of Queensland, QLS Diverse Abilities Network and the Queensland African Lawyers Network.

In September, WLAQ also co-hosted the successful "Why Diversity?" event at the Banco Court in collaboration with many of the above organisations. The Honourable Walter Sofronoff moderated the event and there was a wonderful sharing of

SOCIAL SECRETARY REPORT

2021 was an excellent year for events hosted and supported by the WLAQ.

While things may have started off a bit rocky, and we had a few lockdown interruptions throughout, the resilience of our committee to reschedule events again (and again!) led to a fantastic, albeit busy, year of events for the WLAQ

We held our monthly breakfasts in Brisbane where casual networking provided an easy access point for many members.

For the first time, we also provided remote access to the event, with viewing parties in many regional cities. This is a service we as a committee hope to be able to provide again in the future. We were also delighted to use this event to raise much needed funds for the Women's Legal Service.

In November 2021, we were able to host the annual Women at the Bar event at the Inns of Court after a long hiatus. It was great to hear from guest speaker Jodie Wooldridge QC (now Judge Wooldridge QC) regarding her path at the bar and celebrate her appointment as silk.

Throughout the year, the WLAQ Criminal Lawyers Sub-Committee was also active with events aimed at tackling the unique issues faced by female criminal law practitioners - especially in the area of personal wellness and balancing life as a criminal lawyer with raising a family. The year was capped off with a well-attended Christmas Drinks at Cicada in Brisbane City which celebrated the fantastic events spearheaded by the Sub-Commitee over the past year.

As a committee, we are thankful for all our members who supported our events in 2021 and are so excited to continue to deliver events to our WLAQ community in 2022.
