The success of the 2018 year was achieved thanks to the hard work of the FY2018 and the FY2019 Management Committees under the leadership of Cassandra Heilbronn, who, from 1 July 2019, I succeed as President. The significant momentum of the FY2018 Management Committee was built on by the subsequent Management Committee and I thank them all for their dedication.

The 2018 calendar year was a massive year for WLAQ events and we were excited to celebrate our 40th Anniversary. The anniversary was commemorated by our Awards Gala, where we reflected upon the amazing women who initiated WLAQ and the efforts and contributions of those involved since this time. Together we have caused for, created and witnessed a significant amount of change for women in law and we acknowledge the ongoing need and importance of this organisation moving forward.

Being WLAQ's first regional President, it was important to me that we aimed to increase our involvement and support of women in law throughout all areas of Queensland. Our Ambassador and Advisor program was rolled out, and WLAQ set a goal of hosting an event in every region in FY2018, which saw WLAQ near double its annual events. This initiative has been extremely well supported by our Management Committee, Ambassadors and our regional members. The events WLAQ hosted included the WLAQ Breakfast and Lunch Clubs, networking evenings, Senior Women-In-Law lunches, educational seminars, and Inter-Professional Evenings. All of these events were in line with our 2015-2018 Strategic Plan and were aimed at strengthening WLAQ's support and referral networks. We look forward to further developing our regional initiatives for the benefit of regional women in law in the year ahead.

As part of our continued focus to support all of our members, thanks to the events initiated by Magistrate Thacker and Wendy Mulcahy, WLAQ started its WLAQ Female Criminal Lawyers focus group and appointed its first Criminal Law Advisor.

This Annual Report provides a summary of WLAQ's 2018 activities, and when reflecting over the past year, WLAQ is proud of its efforts. The inaugural WLAQ Inspo List resulted in a an unprecedented response from the profession, we launched the WLAQ Parental Leave Survey (with the Report published in 2019) and continued our involvement with the Judicial Appointment Advisory Panel. WLAQ looks forward to progressing initiatives for women in law with the support of the Bar Association of Queensland and Queensland Law Society.

Finally, thank you to everyone who has made me feel incredibly welcome during my first year as President. I look forward to undertaking another year as President of WLAQ during FY2020.

## **AWL REPORT**

 Ann-Maree David, WLAQ President, AWL Immediate Past President & CEO of The College of Law Qld

Australian Women Lawyers Limited (AWL) was established on 9 September, 1997. AWL is governed by a Board of directors comprising representatives from each State and Territory women lawyers' associations. I am proud to represent the Women Lawyers Association of Queensland on that Board and currently serve as Immediate Past President.

The AWL Annual General Meeting was conducted in Melbourne in November 2018. The elected Board Executive comprises:

- Ann-Maree David, Immediate Past President (WLAQ)

The highlights of the past year include the biennial AWL Conference held in Sydney. Themed, "Investing in the Future", the conference sought to capture current issues of innovation and technology and the law, including essential tools for furthering diversity and inclusion, quality leadership, best practice, flexible work options, the achievement of policy and law reform, and attainment of access to justice. Queensland women lawyers were strongly represented at the conference with attendance by judges, barristers, solicitors, academics and law students and the WLAQ Delegate. The next AWL Conference will be conducted in Melbourne in August 2020.

AWL made representations to the AHRC Inquiry into Sexual Harassment in Australian Workplaces at both round tables conducted around the country and in a formal submission. AWL has since convened a national forum of women lawyers to address immediately-actionable items which had been included in independent submissions to the AHRC made by the various women lawyers' associations.

Finally, the 2019/2020 AWL strategic maintains a strong focus on addressing both sexual harassment and the gender pay gap in the legal profession. In that later regard, I remain the AWL's representative on the Foundation Board of the Australian Gender Equality Council (AGEC). The AGEC conducted a national forum in Melbourne in April at which drafting of the organisation's manifesto commenced. Once finalised, this will be circulated via AWL to all women lawyers' associations.

## **MEDIA REPORT**

- Katrina Mawer, WLAQ Media Advisor & Solicitor, Barry. Nilsson Lawyers

In 2018, WLAQ Media continued to expand its reach in connecting women across all areas of our profession to events, inspiring content and each other. WLAQ now reaches over 800 accounts on Twitter, 1,200 on LinkedIn and 3,000 on Facebook. In 2018, we increased our followers by some 36% across all social media platforms.

Last year, we began utilising Facebook Event pages to better connect with our membership base. These pages allow our members to easily indicate their interest, purchase tickets and share events with their extended networks. The aim is to connect WLAQ members and non-members alike in targeted events for their practice area or area of interest. Expanding our focus to the regions, WLAQ Media developed specific Facebook groups for our regional areas including the Wide Bay, Ipswich, Rockhampton, Sunshine Coast, Atherton Tablelands, Cairns, Mackay, Townsville, Gold Coast and the Darling Downs region. The purpose of these groups was to better engage with our regional members, notify them of region-specific events and promote open discussion. WLAQ also created its first practice-area specific Facebook group for female criminal lawyers. These groups provide an opportunity for members to privately interact with each other, share industry news and communicate regarding events.

WLAQ Media is proud to use its platform in the community to inspire, connect and support women of all levels of our profession. It is our hope that WLAQ's social platforms encourage members (and non-members) to reach out, engage, start a conversation and lean in to the issues facing our profession.

## **ADVOCACY REPORT**

- Jessica McClymont, WLAQ Vice-President & Barrister, Hemmant's List

WLAQ continued to actively undertake work to support women in the profession. One of WLAQ's most successful initiatives is that of its Female Barristers List, which is a resource for those seeking to pursue equitable briefing of the bar.

WLAQ received a number of notifications of legislative changes and enquiries including a request to provide a submission regarding the amendments to the Review into termination of pregnancy laws in Queensland. Many invitations to provide a submission related to legislation that did not concern the core objectives of WLAQ, in which case, the call for submissions was circulated among WLAQ members for their interest.

WLAQ will continue to be involved in responding to proposed legislative changes and matters concerning our members. The Management Committee look forward to working with its members on any areas of the profession that are a cause for concern.

## **DIVERSITY REPORT**

#### - Nicole Morgan, Chair of Diversity & Senior Associate, Minter Ellison

Consistent with the objective of WLAQ's Diversity Committee to ensure diversity of women in all levels and areas in the legal profession and to ensure women in law are not leaving the profession due to a lack of proper systems and support which would allow them to continue working, WLAQ's Diversity Committee focussed its strategic efforts on the following initiatives:

- In celebration of WLAQ's 40th anniversary, on International Women's Day 2018, WLAQ launched its inaugural WLAQ's Inspo List, by releasing a list of women that have inspired the WLAQ Committee over the course of their careers. The WLAQ Inspo List was released for the first time in 2018 and was welcomed by many (so much so, it crashed our website!).
- Recognising and supporting pregnant barristers by tailoring a Bar jacket (with the assistance of The Fitting Room on Edward) so that it could be used by pregnant barristers throughout the later stages of their pregnancy. The jacket has been tailored to include an 'expanding pleat' at the back of the jacket to allow for it to be used by women at all stages of their pregnancy, while keeping the fit of the jacket as comfortable and flattering as possible. Since its release, the jacket has been used by a number of practitioners.
- Encouraging and promoting diversity in the regions by appointing engaged and motivated regional Ambassadors, consistent with our WLAQ strategic objective to increase the focus and support for female practitioners in regional areas. WLAQ is on track to have completed its objective of holding at least one event per region throughout Queensland in FY2019.
- Launching the WLAQ Parental Leave survey, in order to understand what was being offered in the industry to achieve awareness amongst our members and amongst employers about this very important issue. These results were published in FY2019.

In addition to our events throughout the year including WLAQ's Family, Career & Life: It's your choice seminar held in August 2018 where speakers shared their real life stories and expertise about family, career and life matters, and our Ladder mentoring program, WLAQ is committed to diversity initiatives through our online resources.

WLAQ is a signatory to the Law Council of Australia's National Model Gender Equitable Briefing Policy and WLAQ has produced and maintains, on its website, a Female Barristers List, to assist lawyers with equitable briefing practices by finding a female barrister to consider briefing in a specified practice area.

Additionally, WLAQ's website provides information on Flexible Work Practices, and its Friends of WLAQ initiative is designed to provide support to women more than 7 years PAE by having access to a verified list of people (female and male) from the legal profession who they can call on to discuss any issues. WLAQ also supports the work of Circle In, which provides practical assistance for those returning to work and workplace strategy.

WLAQ thanks and acknowledges all of those who contributed to its Diversity initiatives in 2018.

## STUDENT REPORT

#### - Emma Lewis, Student Representative

The role of the Student Representative is to facilitate connections with law students throughout Queensland and provide support to other Committee members, such as the Social Secretary, in the planning of events.

2018 was a great year for student engagement with WLAQ. The QLS Careers Expo in March 2018 was a highlight with WLAQ operating a booth and speaking with students throughout the day. Committee members volunteered their time to discuss the role of WLAQ, benefits of membership and operation of the Mentoring Program. The Mentoring Program proved particularly interesting to many attendees who were looking for female mentors within the profession. Attendees were also able to place their name on the WLAQ mailing list with the potential to win free WLAQ membership for one year. Over 100 names were added to the list on that day. WLAQ also provided merchandise to all of those who visited the booth.

The Una Prentice Awards provided a fantastic opportunity for the female law students with the highest GPA from each law school in the State to come together for a night of celebration. It is clear that female law students are continuing to engage with the legal profession both within and outside of their studies and are achieving phenomenal results. Many faculty members from represented law schools were also in attendance.

It is hoped into next year that student engagement continues to grow with a view to further expand our profile within the student community and foster connections with law schools across Queensland.

## SOCIAL SECRETARY REPORT

In 2018 WLAQ increased the number of events it hosted, with a focus on the regional areas. The Committee has been incredibly excited about its regional events and sees this as a step towards achieving a strong network within our regional communities.

February started with our Toowoomba Inter-Professional Event which had over 50 registrations. In March, WLAQ and the Far North Queensland Law Association co-hosted its International Women's Day Breakfast. WLAQ was present at the QLS Careers Expo and engaged with a number of students, and our FY2018 President attended the Governor's International Women's Day Afternoon Tea with a mentee.

WLAQ also sponsored a member to attend the Biannual Australian Women Lawyers Conference in Sydney in August. With the warmer weather, WLAQ re-ignited its monthly Brisbane Breakfast Club which continues to receive wonderful feedback from our members, who enjoy the casual and easy way to connect with other members in the profession.

September saw the annual Women at the Bar Event which was a fantastic opportunity for lawyers and barristers to connect and to hear from Darlene Skennar QC. Our Rockhampton Ambassador hosted a successful networking function for our lawyers in the Rockhampton Region.

In October, WLAQ hosted its 40th Annual Gala Awards Dinner, which was a fantastic celebration of some of our incredible colleagues in the profession and the work WLAQ has accomplished in the last 40 years.
